Rules and Regulations

**It is the goal of the Tournament Committee to ensure that all divisions are matched according to team skill level and therefore provide fair and balanced tournament.**

**To all Tournament Participants:**

1. CAHA and SCOHA rules shall apply EXCEPT where listed below. CARHA sanctioned.
2. Team representative must register at the arena where team's first game is scheduled one (1) hour prior to first game.
3. Teams must be available to play thirty (30) minutes prior to their scheduled game time.
4. Proof of Age (Birth certificate, Passport, Etc.), must be available if requested.
5. Each team will be guaranteed three (3) games.
6. All games will be two (2) periods of 15 minutes stop time, second period will be running time for last five minutes if there is a five (5) goal differential.
7. Intent to injure and fighting penalties will result in the player being expelled from the game and the remainder of the tournament.
8. Two (2) points will be awarded for a win, one (1) point for a tie. There will be no overtime during round robin series.
9. The first game in a cross-over division cannot end in a tie. If tied at the end of regulation time, a sudden victory shoot-out will take place. Home team will decide if they shoot first or shoot second; shooters go individually. Both teams will **shoot 3 times** and the team with the most goals wins. (Teams will inform the timekeeper who their 3 shooters are at the end of regulation time)  
Any Player serving a penalty that has not expired at the end of regulation time is ineligible to participate in the shootout.  
If the 2 teams are tied at the end of the shoot-out, the following tie breaker format will be used:
  - i) team that scored the first goal in the game is declared the winner.If the game end in a 0 – 0 tie, the following tie breaker format will be used:
  - i) team with least penalty minutes is declared the winner.
  - ii) team that got first penalty loses the game
  - iii) Toss of a coin / home team calls it in the air / winner of coin toss is declared the winner.

**Winning team is awarded 2 points, team that loses is awarded 0 point to be carried over into the division they are placed in.**

10. a) In the event of two (2) teams tied after round robin series, the following tie breaker format will be used:

- i) Record against other tied team
- ii) Total wins
- iii) goals for minus goals against (+ / -)

**(note A)** difference between goals scored by a team and the goals scored against that team over the 3 game round robin.

**(note B)** for the purpose of applying this step, the greatest factor used will be +6 goals.  
 > example; if the actual score of the game is 10-0, a number factor no greater than (+) plus 6 will be given to the winning team and a factor of (-) minus 6 will be given to the losing team.

- iv) Least goals against over the 3 game round robin.
- v) Least penalty minutes over the 3 game round robin.
- vi) Toss of a coin

b) In the event of three (3) or four (4) teams tied after round robin series, the following tie breaker format will be used:

- i) goals for minus goals against (+ / -)

**(note A)** difference between goals scored by a team and the goals scored against that team over the 3 game round robin.

**(note B)** for the purpose of applying this step, the greatest factor used will be +6 goals.  
 > example; if the actual score of the game is 10-0, a number factor no greater than (+) plus 6 will be given to the winning team and a factor of (-) minus 6 will be given to the losing team.

- ii) Least goals against over the 3 game round robin.
- iii) Least penalty minutes over the 3 game round robin.
- vi) Toss of a coin

11. In the case of sweater color conflict, the home team will change.

12. Maximum number of Jackets per team will be fifteen (15). (4-L / 8-XL / 3-XXL )

13. No time outs allowed in round robin play. A 30 second time out will be allowed for Final games.

14. In the event of a tie, Playoff Games will be decided by;

1) Four (4) minutes stop time, sudden victory - Four (4) skaters plus a goalie, change only on the fly. Any penalties in regulation play carries over into the overtime.

2) If still tied, a sudden victory shoot-out will take place. Home team will decide to shoot first or shoot second; shooters go individually. Both teams will **shoot 3 times** and the team with the most goals wins. If still tied, the 4th shooters go and then on down the shoot out list. This is sudden death; first to score while the opponent fails to score, wins.

Any Player serving a penalty that has not expired at the end of the four minute overtime is ineligible to participate in the shootout. All players must have had a shot prior to a player taking a second shot.

15. No Slap shots (knee height) or Fake Slap Shot - 2 Min. penalty

16. Visors are recommended but not mandatory

17. If a player makes contact with the puck above his shoulders, play is blown dead and face off to take place. (no penalty is assessed)

18. Three (3) minor penalties – automatic expulsion from that game only.

19. Protective Equipment - Helmets-

A player on the ice whose helmet comes off while play is in progress, shall not participate in the play in any manner without their helmet.

The player must immediately

(A) proceed to the players bench or

(B) put the helmet back on with the chin strap properly fastened.

Player may not return to the ice without a helmet.

If a player participates in the play in any manner without their helmet, the play must be stopped immediately.

A 2 Min. penalty shall be assessed to the offending player or players. (illegal equipment)

20. The Tournament Committee reserves the right to make decisions regarding the interpretation of these rules.
