



## SCOHA COVID-19 Individual Screening Form

### Column A

- I confirm that I am not experiencing or been in contact with anyone with any of these COVID-19 symptoms either at the time of signing or on any day when I will be coming to the rink:
  - Fever or Signs of Fever
  - Shortness of breath or New cough or Worsening chronic Cough
  - New Onset of Fatigue or Muscle Pain
  - Runny nose, headache, sore throat, or Diarrhoea
  - Lost of taste or smell or Purple Fingers or Toes (Even as the only Symptom)

### Column B

- I confirm that I have not been in contact with a person who has been diagnosed with COVID-19 within the past 14 days and that I will not come to the rink in future if this is the case.

### Column C

- I confirm that I have been practicing and will continue to proper social distancing of 2 meters/six feet and proper sanitation protocols including repeated hand washing and Hand sanitizer use to do my part to decrease the risk of contracting and transmitting the COVID-19 virus.

### Column D

- I verify that I have not travelled outside Canada within the past 14 days and will self-isolate for 14 days in future prior to coming to the rink if I do so.

### Column E

- I agree to wear a mask in Designated areas well with in the Building.

# WAIVER FOR ADULT PARTICIPANTS

## ACKNOWLEDGEMENT AND ASSUMPTION OF RISK

**I UNDERSTAND AND AGREE** that there is potential risk for injury involved in the training and participation of any physical activity. I further understand and agree that participating in hockey is a potentially dangerous activity. Bumps, bruises, scrapes, scratches and soreness are commonplace, and most participants will encounter this sort of minor injury from time to time. More serious injuries are possible, including sprains, strains, twists, cramps, fractured bones, broken bones, torn ligaments and injuries of similar magnitude. Participation also includes possible exposure to and illness from infectious and communicable viruses and diseases including influenza and COVID-19. While particular rules and guidelines may reduce the risk associated with participation, the risk of serious illness and death does exist.

I am also aware that I should discuss my participation in any CARHA Hockey activity with my physician to determine the effect on my current health. It is my right and responsibility as a participant to immediately remove myself from participation in the program and notify the nearest official, if at any time I sense any unusual hazard or unsafe condition or if I feel that I am physically, emotionally, or mentally unfit for continued participation in the program.

I acknowledge my responsibility to ensure adequate medical personal health, dental and accident insurance coverage, as well as protection of my personal possessions.

**I FREELY ACCEPT AND FULLY ACKNOWLEDGE ALL SUCH RISKS, DANGERS AND HAZARDS, RESULTING FROM MY PARTICIPATION IN ANY EVENT HOSTED OR SPONSORED BY CARHA HOCKEY AND HAVE READ AND UNDERSTAND THE ABOVE STATEMENT OF RISK. I ASSUME RESPONSIBILITY FOR MY OWN SAFETY, AND I UNDERSTAND AND ACCEPT THE RISKS INVOLVED WITH MY PARTICIPATION.**
